## RE: COMMUNITY CONSULTATION – WEST STREET – PROPOSED CHANGES TO PARKING RESTRICTIONS

Following community consultation held between 9 July 2024 and 10 September 2024 on the proposal to convert two sections of unrestricted parking on West Street to "1P 8:30am-6pm Mon-Fri Permit Holders Excepted Area 21", it was identified that a proposed "2P 8:30am-6pm Mon-Fri Permit Holders Excepted Area 21" restriction may better align with community needs based on submissions received.

As a result, Council is considering a proposal to convert two sections of unrestricted parking to "2P 8:30am-6pm Mon-Fri Permit Holders Excepted Area 21". The proposal would also address resident concerns regarding vehicles parking for extended periods, low turnover and availability of parking.

The proposed "2P 8:30am-6pm Mon-Fri Permit Holders Excepted Area 21" restriction would limit any vehicle without a valid parking permit to parking for a maximum of two hours between 8.30am and 6pm Monday to Friday. The change would encourage a turnover of vehicles and improve the likelihood of the availability of parking.
