Dear Resident/Occupant,

**RE: COMMUNITY CONSULTATION – BROUGHTON STREET, KIRRIBILLI – PROPOSED RELOCATION OF  
A LOADING ZONE**

Council is proposing the relocation of the Broughton Street loading zone to be moved closer to Crescent Place, Kirribilli.

The proposal comes due to Council receiving concerns about the disruption caused by delivery vehicles when unloading on Crescent Place, resulting in access issues for other vehicles. A sketch of the proposal is attached.

The relocated loading zone would state “**Loading Zone 9:30am-6pm Mon-Fri**”. The restriction would prevent a driver from parking in the area where the sign applies. Vehicles can briefly stop to drop off or pick up passengers during the loading zone time period. In accordance with NSW Road Rule Reg 179(2), the restriction would allow delivery drivers to undertake loading and unloading activities for up to 30 minutes at a time.

The proposal would alter the current loading zone to “**½P 9:30am-3:30pm Mon-Fri, 8:30am-12:30pm Sat**”. This restriction would prevent a driver from parking in the area where the sign applies for more than 30 minutes between 9:30am-3:30pm Monday to Friday, and 8:30am-12:30pm Saturday.

Existing “No Stopping” restrictions would remain unchanged.
