Grasmere Reserve Playground update

1. Introduction

The purpose of this project-specific Communications & Engagement Plan is to outline the ways stakeholders can be involved in the decision-making process regarding finalisation of the concept plans for the upgrade of Grasmere Reserve Playground, in Benelong Ln, Cremorne. In accordance with Council's *Playgrounds Plan of Management* and *Playgrounds Methodology*, we are committed to ensuring that the new playground best meets the needs of users and the local community.

1.1 Council's Community Engagement Strategy

2. Background

Council developed a *Playgrounds Plan of Management* in recognition of the importance of playgrounds. The Plan led to the development of a Playgrounds Methodology, which prioritise all of the Council's playgrounds according to their need for progressively and strategically upgrading the valued community assets. The *Playgrounds Methodology* is used to inform the Council's Capital Works Program.

The existing Grasmere Reserve playground was last upgraded in 2003/04. Council is committed to revitalise this facility while retaining the beautiful, leafy, garden character of the existing playground. The proposed upgrade will aim to retain some of the existing elements balanced with increase functionality and accessibility, and where space permits some new play elements will be added.

The project's objectives are to create a refurbished playground that:

- provides a safe and engaging space to promote physical activity and social development
- retains the existing leafy, garden character of the current playground;
- provides a variety of play equipment, for a range of ages and abilities
- provides a pleasant environment for parents and carers, with adequate (informal) seating positioned to facilitate easy supervision; and
- provides maximum play value by offering many different types of activities (spinning, swinging, sliding, balancing, climbing etc)

3. Community Engagement Strategy

3.1 Who are our community stakeholders?

The Engagement Strategy identifies the following groups to engage within the local community:

- local residents
- park users/visitors
- Precinct Committees, in particular Brightmore Precinct
- Sport & Recreation Reference Group
- Council staff
- Councillors

3.2 Key Communication Messages

- Grasmere Reserve Playground is due for an upgrade, as identified in Council's *Playgrounds Plan of Management* and *Playgrounds Methodology;*
- The community can give feedback on the proposed design option by 9 February 2025
- If adopted, the new playground would be ready to open in 2025.
- the upgrade seeks to retain some of the existing playground elements which have served the community well and have been much-loved, as well as to increase safety, functionality and accessibility. Where space permits, some new play elements will be added

3.3 Timetable

Stakeholder engagement will occur at various times during the project. The key project phases are outlined in the following table:

3.3.1 Phase 1 - Research/Scoping

This phase involved preparing a playground design option with a unique character and a set of activities that caters for pre-school and school aged children. The proposed upgrade will provide a cohesive play facility that continues to sit neatly into the surrounding landscape, providing parents and carers with comfortable supervision points and children of all abilities with a safe, stimulating and challenging play space where they can interact with their friends and enjoy this beautiful parkland setting.

3.3.2 Phase 2 - Public Exhibition

A detailed concept plan has been prepared within budget constraints for this project. Public exhibition will commence on 20 December 2025 for 52 days, with various inform methods used to ensure stakeholder awareness of the opportunity to provide feedback on the proposal and allow for participation at times that best suit individual needs and commitments.
